1) ITEMS THAT ARE RETURNED AFTER 180 DAYS
2) ITEMS THAT HAVE BEEN USED

2) ITEMS THAT HAVE BEEN OSED

3) ITEMS NOT DEEMED TO BE RESALABLE

**4)** ITEMS THAT ARE MARKED, LABELLED, OR HAVE BEEN USED

5) ITEMS THAT HAVE BEEN DISCONTINUED

**6)** SPECIAL ORDER ITEMS

**7)** CLEARANCE ITEMS

8) ITEMS THAT FALL IN THE "FINAL SALE BRACKET ABOVE"

RETAIL PRODUCT WILL BE ACCEPTED AS DAMAGED AND REPLACED FOR THE CUSTOMER FOR DAMAGES RESULTING FROM A MANUFACTURING DEFECT.

RETURNS ARE ISSUED AS A CREDIT ON ACCOUNT AND WILL NOT BE REFUNDED IN THE ORIGINAL FORM OF PURCHASE.

0 - 60 DAYS FROM ORIGINAL PURCHASE

0% RE-STOCKING FEE, FULL CREDIT GIVEN

60 - 90 DAYS FROM ORIGINAL PURCHASE 20% RE-STOCKING FEE

90 - 120 DAYS FROM ORIGINAL PURCHASE 30% RE-STOCKING FEE

120 - 150 DAYS FROM ORIGINAL PURCHASE 40% RE-STOCKING FEE

150 - 180 DAYS FROM ORIGINAL PURCHASE 50% RE-STOCKING FEE

AFTER 180 DAYS (6 MONTHS ) FROM ORIGINAL PURCHASE
NO RETURNS OR EXCHANGES = 0% CREDIT GIVEN

### **DEFECTIVE / DAMAGED ITEMS**
